COMPLETE AND RETURN THIS PERMIT APPLICATION to the **BOROUGH OF MACUNGIE OFFICE, 21 Locust Street, Macungie, PA 18062. Once you receive your sticker/pass, affix the sticker to the **inside**, on the **LEFT** (drivers) side of your vehicle, so it is easily seen upon entry to the site. Examples for placement: left side top corner of windshield or left side lower corner of windshield (not too close to the inspection stickers).**

Anyone without a sticker will be turned away.

Lost Sticker? There is a \$10.00 fee for replacements. Fill out an application at the Macungie Borough Offices and a new sticker will be given to you. **CASH or CHECK ONLY.**

Selling your vehicle? Please remove the sticker from your vehicle and turn it in when you apply for a sticker for your new vehicle.

LANDSCAPERS, LAWN SERVICES AND TREE SERVICES CANNOT USE THE SITE. Any applications will be denied.

Site Rules and Regulations

HOURS OF OPERATION

CLOSED EVERY TUESDAY & THURSDAY & ALL TOWNSHIP HOLIDAYS

JANUARY & FEBRUARY Mon., Wed., Fri., & Sat. - Noon to 5PM

MARCH & APRIL Mon., Wed., Fri., Sat. & Sun. - Noon to 5PM

MAY 1 to 31 Mon., Wed. & Fri. - 9AM to 7PM - Sat. & Sun. - Noon to 7PM

JUNE 1 to OCTOBER 31 Mon., Wed., Fri. & Sat. - 9AM to 7PM - Sun. Noon to 7PM

NOVEMBER & DECEMBER Mon., Wed., Fri. Sat. & Sun. - Noon to 5PM

We do not allow landscapers, commercial lawn or tree services to deposit yard waste or pick up mulch/humus at our facility. It is strictly for use by private residential homes. If you have hired a service for yard work, your contractor is responsible to remove the waste to an approved site other than this facility. We also do not allow golf courses, business complexes, etc. We suggest that these enterprises utilize their own waste hauler or other (commercial) sites.

Materials are processed into either mulch or humus and therefore must be separated. **Yard waste must be removed from bags/containers.** To keep our costs down and to keep the site clean, please carry out your bags and containers.

ACCEPTABLE WASTE

FOR MULCH:

Branches from trees
Firewood
Limbs/tree stumps – **up to 12 in. diameter**
Rootballs - **up to 24 in. diameter w/soil & debris REMOVED**
Woody stems from hedges/forsythia bushes
Pinecones
Sweet gum balls
Rose plants
Nuts
Ornamental grass
Pine needles
Corn stalks

FOR HUMUS:

Mowed grass
Leaves
Pumpkins/apples
Straw
Garden plants/garden waste
Flowers/ flower plants
Flowerpot soil
Soft hedge trimmings

PROHIBITED WASTE

Pallets
Drywall/Sheetrock
Dirt/Rocks
Landscaping stone

Bricks
Railroad ties
Trash/garbage/household waste
Plastic of any kind

Dimensional construction lumber
(decking, etc.)

We suggest that you separate your yard waste before visiting the site so that you can easily discard items into the appropriate piles.

We supply residents with mulch/humus based on availability. While it is available, you may shovel/load the mulch/humus yourself during regular business hours.

→ Every Saturday during the months of April and May we offer a loading service from 7:30AM to 11:30AM and every Thursday in April from 1PM to 3PM, while supplies last. Currently there is a \$20.00 fee per loader scoop. *This charge could change without prior notice.*

There can be no refuse drop off while compost is being loaded. Due to traffic safety concerns, we recommend you do not come to the site until 1PM on Saturdays during the loading season to drop off yard waste or to shovel/load mulch yourself.

We recognize that we have many residents who own commercial vehicles and who are not landscapers or lawn service contractors. In these instances, we will allow commercial vehicles on site.

VEHICLES OVER 10 TON AND TRI-AXLE VEHICLES are prohibited. *This is subject to change without prior notice.*

We reserve the right to disallow and/or refuse entry to anyone that we believe could be involved in commercial enterprises and/or who are in direct conflict with our policies related to disposal of yard waste. We also reserve the right to disallow and/or refuse entry to anyone who poses a threat to Recycling Center employees.
