e. JHA - Mavis Tire - Waiver Request

- 8. Discussion with the Zoning Officer about current activities
 - a. 28 permits submitted since the last meeting, 10 for Fields at Brookside, 25 issued, 6 pending BIA, and 7 under review.
 - b. 2 residential rental units were inspected, and 5 are scheduled for 2/22. 47 inspections were completed in 2023.
 - c. Zoning Hearing Board denied Appeal 2023-05 138 Thorn St.
 - d. Zoning Hearing Board Appeal 2023-04 withdrawn
 - e. 124 E Main St. A tentative/Prelim proposal was submitted for Apartments and a Yoga Studio
 - f. Borough Hall and Macungie Institute buildings were inspected due to a resident complaint. Numerous IPMC violations. Meeting with the manager and Public works.
 - g. Stone Hill Meadows an issue concerning the curbing/sidewalk repairs* on Spring Street leading into the development which needs to be addressed as there was debris on the street and excavated areas along the curb line extending 2 feet deep by 2-3 feet wide. The curb and sidewalk repairs were made although it is likely that BIA was never informed, and inspections were not made.
 - h. Brookside Country Club Interior Renovations: Construction plans were submitted for renovations to the existing entrance foyer, bathrooms, and bar/banquet room. Permits were issued on 2/6/2024.
 - i. A warning letter was issued on 12/29/ 2023 to 40 Locust Street concerning ten (10) violations of Borough ordinances and the IPMC., the main violation being bricks falling from the 2nd floor onto the neighbor's property.
