- b. 333 Residential Rental Inspections have been performed to date. 239 in 2024, 47 in 2023.
- c. 3 Zoning Hearing Board meetings were held in 2024.
- d. Zoning Hearing Board is looking for two alternatives to fill vacancies.
- e. John Walsh was hired as a part-time Zoning Officer to resolve a variety of complaints. Focusing on Premise ID and exposed trash container violations.
- f. Turkey Hill is now closed.
- g. South Walnut St Development will be held on 2/18/2025 for Planning Commission
- h. Permits were issued for the Macungie Institute fire alarm system
- i. A garage addition for the Public Works building is in the works to allow for the storage of the new vehicle.
